IF ALL TICKETS ARE SOLD BY THE BONUS DEADLINE:

The draw date for the 100 Days of Winning Cash Calendar Add-On will take place on April 24, May 21 or June 11, between 8:30am and 10:00am, based on the official outcome of Home Lottery ticket sales; (i.e.) Bonus, Early Bird or Final Deadline sellout. All draws will be made at the offices of Deloitte LLP, located at Purdy's Wharf, Tower II, 1969 Upper Water Street, Suite 1500, Halifax, NS, B3J 3R7. Winners will be posted daily beginning July 1.

Only 100 draws for the 100 Days of Winning Cash Calendar Add-On winners will be conducted. The approved RNG software will be used to generate the winning numbers. Only the range of ticket numbers verified as paid for by Deloitte will be eligible for these draws.

PRIZE CLAIM

All winners will be notified in writing by Deloitte LLP as to what they have won and where to claim their prize(s). It shall be the responsibility of a winner to license and insure vehicles from the time of their ownership.
